IGTO nih an bawmh khawhnak zawn tahchunhnak pawl aa tel, asinain rikhiahnak a um lomi cu:

- tuah piak dingin na halmi caan ning tein lehnak pawl;
- ATO asilole TPB bawi pawl tuahsernak;
- awnlai (online) riantuan piak khawhnak;
- ATO asilole TPB nih a ttuanmi fianternak i aamahkhaannak asilole a zami;



- an pawlasi pawl le tuahto ning pawl he aa tlak ning in ATO asilole TPB rianttuannak a dik bak tiin fehternak; le
- ATO asilole TPB nih nangmah he nan ipehtlaihnak ah iruannak le a thian hirhiarnak le cazin an cheknak le hlathlainak an tuahnak pawl telhchih in aa tlakmi thawngpaang na pekmi dihlak an tuaktaannak kha a dik bak tiin fehternak.
